Parade Rules & Regulations

The Benton City Chamber of Commerce is committed to providing a safe, enjoyable, and family-friendly parade experience for all participants and spectators. All entrants are expected to review and comply with the following rules and regulations.

Driving & Participant Conduct

- Reckless, unsafe, or dangerous driving will not be tolerated.
- No participant may possess or be under the influence of alcohol, illegal drugs, or controlled substances during the event.
- Smoking is prohibited during parade staging and throughout the parade route.

Candy & Item Distribution

- Candy, prizes, or promotional items may not be thrown directly into the crowd or roadway.
- Items should be handed out or tossed gently toward the sidewalk area only.
- Children under the age of 14 may not distribute candy unless they are walking alongside the parade entry.
- Any group distributing items must provide adult supervision to ensure spectator safety.

Float & Child Safety

- There must be at least one (1) adult for every five (5) children under the age of sixteen (16) riding on a float.
- Supervising adults must be affiliated with the sponsoring organization.
- Participants may not board or exit moving vehicles or floats except in the case of an emergency.
- Riders may not be picked up or dropped off along the parade route.

Float Spotters

- Every float being towed must have a designated spotter in addition to the driver.
- The spotter must be able to clearly communicate with the driver if an issue arises.
- If the towing vehicle does not have an enclosed cab, the spotter must walk beside the float.

Vehicle Requirements

- All vehicles must be capable of safely completing the full parade route, including turns and clearance areas.
- Entrants are responsible for ensuring their float or vehicle clears trees, utility wires, buildings, and other obstacles.
- All vehicles must be inspected prior to the parade for oil, fuel, water, or other fluid leaks.
- Drivers must maintain a speed no greater than 5 mph and remain within two car lengths of the preceding entry.
- This is a controlled forward-motion parade. Entries experiencing mechanical or safety issues must exit the route immediately and notify a parade volunteer.

Driver Requirements

- Drivers of all motorized vehicles must be at least eighteen (18) years of age.
- Drivers are required to present a valid driver's license and proof of liability insurance at parade check-in.
- Participants should be aware that emergency vehicles may need to exit the parade route if emergency situations arise.

Animal Regulations

- Animals must be listed on the parade application at the time of registration.
- Entrants are responsible for maintaining control of their animals at all times.
- Riders or handlers unable to safely control their animals may be removed from the parade.
- Animal contact with spectators is not permitted.
- Horses must either:
 - Wear manure collection bags or,
 - Be followed immediately by a designated cleanup crew with proper tools and containers.
- Entrants with animals must leave the staging area clean.
- Any entry with animals that does not provide proper cleanup detail may be denied participation.

Animal Staging Area

- Animal and livestock entries will be staged in the pickleball court parking area.
- Animal entries will enter the parade immediately before the fire department.

General Regulations

- Each entrant is responsible for the conduct and safety of all participants associated with their entry.
- Entrants are responsible for ensuring all participants have reviewed and understand these rules and regulations.
- The Benton City Chamber of Commerce reserves the right to deny or remove any entry or participant that fails to comply with parade rules, behaves in an unsafe manner, or disrupts the event.
- Businesses and organizations walking in the parade are encouraged to carry banners identifying their organization or company.

Lineup & Staging Instructions

- Non-parade vehicles are not permitted within the staging area.
- Drop off for walkers will be on the corner of 13th & Grace Ave.
- The lineup area may become congested with pedestrians, children, animals, and vehicles. All participants must use caution and yield to pedestrians when necessary.

Check-In Location

The parade lineup will begin at the Kiona-Benton Middle School bus parking lot on Grace Ave.

All entrants must:

1. Check in at the registration table upon arrival.
2. Receive lineup instructions before entering the staging area.

Parade Route

The parade route will:

- Begin on Grace Ave. Enter off 13th Street
- Continue down 9th Street
- End at Chris Ave
- Participants leaving town may continue on Babs Avenue.

Participants returning to the staging area should:

- Turn right onto Chris Avenue
- Continue back toward Grace Avenue
